## 5-Story Apartment Building Proposed for Brookside

Members of a Houston-based development company, Bomasada Group, Inc., presented a proposal to build a fivestory apartment building to the Brookside Neighborhood Association at its monthly board meeting on January 14th, 2008. The development company promises that this will be an upscale complex consisting of approximately 250 units at the southwest corner of 39th and Rockford Avenue. The multi-family project is to take the place of the older one-story apartment units currently located there. The facility plans to have indoor and outdoor swimming pools, fitness center, billiards room, wine bar, cyber café, and more. A parking garage is planned for the first level and the other four floors will consist of one and two bedroom apartments. Rent would run from \$800 to \$2000 per unit per month based on size.

The proposed building's elongated front in height to meet the 35 feet maximum will face 39th street and sit across from the multi-family condos to the north. The building will be situated directly behind the Food Pyramid to the west. A surface parking lot will occupy the skinny portion of the property behind Wild Oats along 41st street. The side of the building running

along Rockford Avenue will face singlefamily homes to the east.

The Brookside Neighborhood Association hosted a public forum meeting on February 20th to provide area residents with the opportunity to learn about the project. John Gilbert, Senior Vice President residents of the 108 unit complex were for the Bomasada Group, entertained questions and offered information during the meeting, including 2-dimensional drawings and photographs. Homeowners living directly across from the planned project questioned the proposed size of the new building. Residents wanted to see a 3-dimensional-scale model showing the building's size, scope, and distance in relationship to their homes.

The portion of the building running along Rockford Avenue, adjacent to the single-family homes will be three stories allowance for residential zoned areas. In order to build any part of any structure taller than 35 feet will require a variance from the City Council and TMAPC. The Bomasada Group has stated that the five stories will reach upward to 55 feet.

The Bomasada Group has allowed for

1.73 parking spaces per apartment unit in their design. The requirement is less than that but those 1.73 spaces per unit include the 20 parking spots designated for visitors. The existing property is for sale by owner Perry Properties. Many of the current present at last week's meeting to express their concerns about their possible displacement.

It is the understanding of the BNA that the Bomasada Group wants the input and support of the residents. However, after the public forum it became clear that the Brookside Neighborhood Association Board cannot support or object to this project. The Bomasada Group plans to complete their design and present it to the Tulsa Metropolitan Area Planning Commission, a portion of INCOG and the Tulsa City Council. 
#### **DEBRIS IN CREEKS CAN RESULT IN FLOODING**

Last December's ice storm left large amounts of limbs and debris in the creeks and drainage channels throughout Tulsa. Blockages in the creeks and channels can cause flooding during heavy rains, so they need to be kept clear and free-flowing. Most of these creeks and channels are on private property, and maintenance is the responsibility of the property owner or the local homeowners association.

However, City of Tulsa crews will remove blockages in private creeks and channels that could cause a significant flooding hazard.

Call the Mayor's Action Center at 596-2100 to schedule an inspector to assess your creek.

With the spring rains approaching, the city is asking citizens to be proactive and work at clearing their private channels to reduce the risk of flooding. Do not dispose of limbs and debris from your yards by throwing them into a creek or channel. This not only increases the risk of flooding, but is illegal and punishable by a fine of up to \$1000. Yard clippings left in gutters and roadways can also be washed into channels and creeks and ultimately end up in the Arkansas River.

#### What to do if you get a notice for a zoning change!

Those living within 300 feet of the property at 39th and Rockford will be receiving a notice from INCOG within the next 30 days, notifying you of the PUD development public hearing. Your options are to go to the public hearing or do nothing.

*Object to the development?* Go to the meeting and sign up to speak. Talking points should address existing zoning, underlying zoning, traffic issues, scale, storm water drainage, and similar topics. Do not talk about property values, your neighbor's dog, the ice storm, or other unrelated issues. You can use examples of other areas of Tulsa that had a negative experience with similar zoning. Only speak if you are a property owner in the area. Do not speak if you only reside on the property.

*Support the development?* Attend the meeting and voice your support.

Count on spending the whole afternoon, because there will be lots of cases heard during the meeting. Get there early. As you enter, there will be a sign-up sheet.

It is up to the residents of Brookside to tell Tulsa Metropolitan Area Planning Commission what you think to help them decide on this precedent setting action.
